- 1. Personnel File Maintenance screen:
 - No. of Children will always reflect as Total number of children qualified for tax relief.
 - Child Relief Point Total child relief point in Number of Child Breakdown list.
- 2. Number of Child Breakdown screen:
 - System will default as 0 if you do not insert any number of children at the text box.
 - 1pt = RM2000 deduction according to the latest PCB ruling.
 - Total number of children qualified for tax relief, Total number of Children and Total Child Relief Point is non-editable field. System will auto calculate based on the amount you key in at the number of children field.
 - Example: If you have 3 children,
 - Child A is 24 years old, working.
 - Child B is 19 years old, studying at Local University.
 - Child C is disable child who certified by Department of Social Welfare, sharing relief with Spouse 50%.
 - You should list down as:
